The Supplier is required to supply, install, and maintain the flood telemetry devices in locations as outlined by the Council.

This procurement supports the Council's risk management strategy and community resilience planning, enabling proactive mitigation of flood-related risks to life, property, and infrastructure. The data collected will also empower the community to make their own decisions on flood prevention.
