The recommendation to award the contract to the named provider was approved at the ICB's Strategic Finance and Commissioning Committee, on the 8th May 2025 and ratified at the ICB Board on 27th June 2025.

There were 3 conflicts of interest identified at the ICB Board meeting dated 27th June 2025, and during the 2025/26 ENHT contract development process.

The non-conflicted members have assessed the nature and risk of the conflicts, and decided to take the following steps:

- The conflicts identified at the ICB board meeting were mitigated by the conflicted members leaving the meeting to ratify the ICB's Strategic Finance and Commissioning Committee approval to award the contract.
- Mitigating actions were put in place for the one conflict identified on the ENHT 2025/26 contract development process which included the conflicted member not being part of any decision making.
