All information returned as part of this PME exercise will assist in the development of the specification, evaluation criteria, pricing structure, and contract award options to ensure this tender opportunity delivers a high-quality service to the Council, whilst being achievable and appealing to the marketplace. It is also the Council's objective to keep this tendering process as simple as possible for all interested parties.
