## **VII.2) Information about modifications**

### **VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

Uplift of £253,009.38 being applied to original contract value of £770,000. Date extension of contract end date from 31/08/2025 to 30/11/2025.

### **VII.2.2) Reasons for modification**

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

Media Zoo have successfully delivered Phase 1 of a 2 phase requirement and as a result have the knowledge and specific know-how to be in a position to deliver Phase 2. Furthermore, Phase 2 is defined as a specific output from the Phase 1 work and will work with the existing services provided under the initial procurement.

This is a substantially small piece of work and would not offer the MOD value for money by competing the requirement. Furthermore, it would require an alternative supplier significant time to get up to speed with the work required as a result of the Phase 1 requirement.
