**Monitoring Devices -** : Monitoring devices are used to monitor health parameters. Examples include blood pressure monitors, pulse oximeters, continuous glucose monitors, and wearable fitness trackers

**Surgical Instruments, Implants, all medical consumables and maintenance & services of equipment/devices.**
