II.2.4) Description of the procurement at the time of conclusion of the contract:

Worcestershire County Council, led by Public Health has commissioned an integrated Public Health Nursing Service. The Public Health Nursing Service will focus on the delivery of the Healthy Child Programme and will provide effective prevention and early

interventions either as a single service or jointly with other services working within the wider early help system. The Service will work proactively with other services, agencies and the VCS to coordinate and deliver packages of holistic care for children, young people and their families. All interventions delivered will be evidence based and clinically led by appropriately qualified staff.

In accordance with the Health Care Services (Provider Selection Regime) Regulations 2023, Worcestershire County Council intends to apply Direct Award Process C to award the Worcestershire Public Health Nursing Contract to its existing provider, Herefordshire and Worcestershire Health and Care NHS Trust.

The service will commence 1 April 2025 and end 31 March 2030. The contract is for a 5-year term with an optional +1 +1 extension.

This contract has an approximate lifetime value of £60,307,170 (this includes the two one-year extensions).

VI.3) Additional information

This is a Provider Selection Regime (PSR) contract modification notice, under the Health Care Services (Provider Selection Regime) Regulations 2023. For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award. This contract has now been formally modified.

VII.1.4) Description of the procurement:

An additional £170,000 per annum is to be made available to the Trust. The additional funding will enable the Trust to recruit specialist SEND focused health visitors, to provide a focused intervention for children that have been identified at the 2.5-year check as requiring support with development or SEND needs. The roles will add an additional layer of early intervention to ensure those with higher levels of need can get the right support early and potentially avoid unnecessary delays on wider service waiting lists. This layer of early intervention is required within our current system to improve outcomes for children with higher levels of developmental need.

Additional capacity will also allow the infant feeding team to expand, enabling the commencement of a new pilot delivering group-based support for parents-to-be to prepare for breastfeeding. Currently capacity only allows the service to deliver support postnatally, however evidence shows if we can more effectively prepare families with information and guidance to breastfeed before they give birth, and build support networks, they are more successful in their breastfeeding journey. Worcestershire is currently performing worse than the national picture regarding breastfeeding rates at 6 weeks. This is something as a county we need to improve to improve health outcomes for babies and mothers.

VII.2) Information about modifications

VII.2.1) Description of the modifications

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

The modification is made at the discretion of the relevant authority and the modification does not render the contract or framework agreement materially different in character and the cumulative change in the lifetime value of the contract or framework agreement, compared to its value when it was entered into, is under 25%.

The modification is effective from 07/08/25. There is no change to the length of contract. The original lifetime value is £60,307,170; with the additional funding, the new lifetime value is £61,497,170

VII.2.2) Reasons for modification

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

PSR regulations allow for modifications under certain conditions. This modification is made at the discretion of the Authority and the modification does not render the contract materially different in character and the cumulative change in the lifetime value of the contract is less than 25%.

The modification will enable the supplier to provide additionality to the delivery of the contract, specifically in relation to recruiting SEND focused Health Visitors and additional capacity in the infant feeding team. The supplier is already providing health visitors and infant feeding and this modification will enhance the current offer to better support children, young people and their families across the county.
