The catering facilities at the Trust include the main dining areas and servery. Across the Trust there are currently 3181 pupils on roll for the academic year 2024/25. Of this figure, 826 pupils are entitled to UIFSM and a further 661 to Free School Meals. TUPE is expected to apply, details of which can be found in the tender documentation. Predominantly all members of the catering team are members of the Local Government Pension Scheme and all details are in the tender documentation.
