The used rail grinder meets the specialist gauging requirements of Nexus rail infrastructure and our operational needs including but not limited to: road/rail travel capabilities, limited noise levels (for Tyne and Wear Metro lineside neighbours), dust collection capabilities, large gradient working, and low minimum curve radius working.
