highest-scoring Tenderer shall be awarded no less than fifty per cent (50%) of the total volume of work available under the relevant Lot and/or Sub-Lot. The balance of the work, if any, shall be allocated to the second-ranked Provider in such proportions and at such times as the Authority may determine.
