The decision to award the contract was made by the Chief Strategy & Population Health Officer. • No declarations of actual, or potential interests by those officers involved in this decision. • The incumbent provider has delivered the following key criteria 1: Quality and Innovation with a value of 30% by achieving the contractual KPIs, 2: Value with a score of 15% by providing a service that is value for money compared to other providers, 3: Integration, collaboration and service sustainability with a value of 16% by collaborative working within the local system, 4: Improving access, reducing health inequalities and facilitating choice with a value of 16% by reducing health inequalities, 5: Social Value with a value of 6% by ensuring the provider is meeting London Living Wage (LLW).
