Sefton Council provides an occupational health service to its employees which it also extends to its Schools, Academies and local organisations through SLA agreements.

# Competitive flexible procedure description

For those bidders that meet the Conditions of Participation, there will be a 2 stage award process.

Stage 2i will comprise of a written submission in response to various Quality and Method Statement questions plus a price submission. The responses to each Quality and Method Statement queston will be scored (0 - 5) according to the Table on Page 35 by a panel of

assessors taken from Sefton Council. A moderation process will take place to determine an agreed score for each submission.

For each Lot up to a maximum of two bidders submitting the highest scoring bids based on quality and price will then be taken through to Stage 2ii of the award process subject to those bidders being able to promote their bid to a successful position with the marks remaining for Stage 2ii of the award process
