- Details of the works are issued to the supplier and a full price requested
- Providing the price is consistent with the submitted rates (within 10% of the estimated price) the contract is awarded
- Where the price is not consistent with the submitted rates (more than 10% over the estimated price) extenuating circumstances may be considered (e.g. emergency works, high complexity, work required outside normal working hours, etc)
- Where the price is not consistent with the submitted rates and no extenuating circumstances justify the increase, a second price is sought from the next lowest price supplier and the scheme awarded based on two quotes.
