The decision was made by the Primary Medical Services Contracting Panel in line with the ICB's Scheme of Reservation and Delegation. There were no declared conflicts or potential conflicts of interest.

The relative importance of the key criteria was weighted as Quality and Innovation 15%, Value 15%, Integration, collaboration and service sustainability 40%, Improving access, reducing health inequalities, and facilitating choice 15% and Social Value 15%.

Integration, collaboration and service sustainability was weighted at 40% as the service must be integrated within Nottingham and Nottinghamshire. NEMS Community Benefit Services is fully integrated within the Nottingham and Nottinghamshire Integrated Care System and has robust relationships with Nottingham and Nottinghamshire ICB, Primary and Secondary Care, Community services and the Mental Health Trust ensuring pathways are integrated and robust information sharing.
