Assessment of the provider was based on evidence available through their existing contract with the ICB including KPI reporting/ review of Governance policies / response to performance challenges, as well as publicly available information, including patient satisfaction.

The provider passed all required measures including in relation to clinical governance, incident reporting and safeguarding, delivery within financial envelope, interoperability with other NHS systems and compliance with equalities legislation. On scored areas, it

scored highly for social value as reflected in their workforce development and clear green plan. They have evidenced an ability to deliver the service on an ongoing basis and have responded when concerns have arisen around the amount of closures working with the ICB to rectify this.
