Scope

Description

The contract that will be awarded as a result of this tender process covers two elements:

- Electrical servicing on a cyclical basis
- Electrical repairs and maintenance based on responsive demand

ELECTRICAL SERVICING

The appointed Contractor will be responsible for the delivery of a comprehensive programme of electrical testing, inspection, and associated maintenance services across the Client's property portfolio.

- Electrical Installation Condition Reports (EICRs): Every 5 years per property
- Emergency Lighting Testing: Every 6 months
- Portable Appliance Testing (PAT): Annually
- Extractor Fan Servicing: Annually

- CCTV System Servicing: Annually
- EV Charging Point Servicing: Annually
- Intake Inspections: Annually

RESPONSIVE REPAIRS & MAINTENANCE

The appointed Contractor will also be required to undertake responsive electrical maintenance and repairs throughout the contract term.

- £2,000,000 excluding VAT
- £2,400,000 including VAT

Contract dates (estimated)

- 1 April 2026 to 31 March 2029
- Possible extension to 31 March 2031
- 5 years

Description of possible extension:

The outcome of the tender process will be a 3-year contract with the option to extend by a further 2 years, up to a maximum 5-year total contract term (3+2 years).

Options

The right to additional purchases while the contract is valid.

Alpha is expected to complete the construction of a new building within the contract period, adding additional properties to the servicing schedule. This, along with other unforeseen building and stock purchases/sales, may alter the number of properties.

Any additional sites will be incorporated on a pro rata basis using submitted rates.

Alpha is also nearing a regulatory threshold in terms of stock numbers, above which increased compliance and audit requirements apply. This may result in additional Contractor involvement during the contract term. While specific expectations are currently undefined, this is noted as a potential future requirement.
