NRT and pharmacotherapy will be supplied, by Wellness advisors generating e-vouchers which will be received by contracted community pharmacists via the online portal, Quit Manager.

Stop smoking aids supplied via community pharmacies, under the new contractual arrangement will:

- Contribute to addressing smoking related health inequalities
- Contribute to meeting system wide priorities, including Kirklees Shared Outcomes, priorities set out in the Kirklees Health and Wellbeing plan, NHS 10-year plan
