This contract was awarded as a Call off Contract via CCS G-Cloud 14 framework. The contract was initially awarded for the period 06.01.25 - 31.07.25.

EA have used the extension option available within the call off contract to extend the contract until 31.03.26.

The original Call off Contract awarded value was £119,218.75.

EA intends to modify the call off contract to increase the call off value by £30,000 to a total of £149,218.75. The modification is justified as additional services are required that EA did not foresee when establishing the contract and to change provider at this time would cause delay in terms of managing a new procurement. The

additional £30k value required is 25% of the original contract value and well below the 50% threshold.
