There are two types of Power Axle on the Victoria line - Power Axle with grooves for fitment of gearbox (also known as Power Plain Axle) and Power Axle with grooves for fitment of gearbox and negative shoe gear (also known as Power Shoe gear Axle). There are 16 Power Plain Axles and 8 Power Shoe gear Axle on a 09TS train, totalling to 752 and 376 axles in the fleet.
