The Borough Council of King's Lynn and West Norfolk intends to form a Framework Agreement for routine and emergency repairs to the Hunstanton coastal defences located in West Norfolk. This framework will consist of up to 4 contractors.

Throughout the duration of the framework, the scope of repairs required are likely to include the following:

- Concrete patch repairs to the seawall, promenade, wave-return wall, slipways and beach access steps.
- Replacement of concrete blockwork units to a section of blockwork seawall.

- Asphalt repairs to sections of asphalt surfaced promenade.
- Mortar joint replacement to a section of blockwork seawall.
- Joint sealant replacement to the seawall, promenade, wave-return wall and slipways.
- Health and safety works to concrete groynes and timber groynes.
