## **VII.2) Information about modifications**

### **VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

In order to ensure continuity of supply of C214 12kV Expulsion Fuses this modification increases the published value from £1.20 million £1.36 million due to increased work programme requirements which has resulted in volume increases, in excess of the forecast at the time of the published Contract Award Notice.

### **VII.2.2) Reasons for modification**

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

In order to ensure continuity of supply of C214 12kV Expulsion Fuses this modification increases the published value from £1.20 million £1.36 million due to increased work programme requirements which has resulted in volume increases, in excess of the forecast at the time of the published Contract Award Notice.
