Following a competitive process, the recommendation is to award the contract for Place Based Infant Feeding Peer Support Service (all 3 Lots) to the National Childbirth Trust (NCT). As they are the provider that passed the checks conducted under the Basic Selection Criteria and provided the lowest Value per Other Key Criteria point score.

Proposed Contract Start Date; 2/1/2026 – 01/01/2029

There is the potential for a contract extension of 2 x 1 year(s) (24 months), depending on both the success in achieving the required outcomes and the availability of further funding.

The total contract value for the full contract should all extensions be enacted is £2,762,108.44
