#### **Description**

The DfE are looking for an end-to-end Top 100 Apprenticeship Employer (and Top 50 SME employers) - Entries & Administration supplier, that includes:

- Management of Top 100 Apprenticeship Employer rankings.
- Confirm entry criteria and application process.
- Quality assurance of all entries and across the whole application process.
- Compile final rankings and all associated resources.
- Analyse and prepare detailed evaluation and data reports.
- Design and Management of content and celebration events.
- Develop and deliver 2-year activities, research, and benchmarking reports.
- Develop and deliver webinars for employers and individuals and support promotional activities.

The DfE is keen to maximise opportunities to participate in procurement for Small to Medium-sized Enterprises (SMEs) and Voluntary, Community and Social Enterprises (VCSEs). Consideration will also be given to consortia and collaborative bids from all forms of organisations.
