Description of possible extension:

As the Business Growth Plan is currently in development, there may be additional funding streams or targeted interventions requiring new or extended grant processes. While current timelines are based on known delivery requirements, further grant administration could be required beyond existing timescales, subject to finalised priorities. These opportunities are expected to become clearer by January 2026.

This introduces known unknowns - we anticipate new delivery activity may emerge, but the scale, complexity, and timing remain uncertain. There is also the potential for unknown unknowns tied to national policy shifts or macroeconomic changes.

If additional grant processes are introduced as a result of the Business Growth Plan, this may require an increase in delivery capacity, resources, and associated administration costs to maintain robust governance, compliance, and monitoring. This would represent a monetary increase not currently budgeted.

This constitutes a known unknown - the potential need is recognised, but the financial impact cannot yet be quantified until delivery models and funding allocations are confirmed in early 2026.
