This needs to be in place on the award of contract and maintain this throughout the initial term of the contract and any extension periods.

The Council also wishes the same Provider to be able to coordinate and provide a wood pellet store cleaning service. It is expected but not guaranteed that for the 17 Core Sites store cleans will be carried out a minimum of once every two years.
