## Description

The CGT Catapult Learning and Development (L&D) and Human Resources (HR) function currently uses a centralised online system which offers a combined Learning Management System (LMS), a Performance Management System (PMS) to support employee learning and development and a complementary talent management tool for talent management and succession planning.

The CGT Catapult Skills team is externally facing and uses a separate LMS to deliver industry relevant training content to customers that is hosted directly on the LMS, and to sign-post relevant training from our third-party partners, which directs users onto external websites (currently known as the Life Sciences Learner Hub (LSLH)). The Skills team also delivers commercial training in-person at our Skills and Training Laboratories and are planning to design digital training which will be monetised and hosted on the LMS.
