This notice confirms that Transport for London intends to use the Railway Industry Supplier Qualification Scheme (RISQS) as a Qualifying Utilities Dynamic Market under Sections 34-40 of the Procurement Act 2023.

Scope of Procurement:

Procurement of 935 cable and associated components for use in rail infrastructure projects.

This notice is published retrospectively due to transitional implementation of the Procurement Act 2023. The procurement was conducted in good faith using RISQS, which meets the criteria of a dynamic market.

Transport for London will continue to use RISQS as a dynamic market for future rail-related procurements and will ensure timely publication of notices going forward.
