Nottinghamshire County Council is seeking an experienced Provider who can deliver care and support for those children presenting with multiple needs for whom we find difficult to find suitable homes for. The cohorts of children the Council envisage being referred into this service are as described in Section 1 of the Specification.

The Provider will have access to a property owned by the Council to deliver care from. This is a property secured with DfE Capital grant funding and will be offered to the Provider under a lease arrangement.
