Description

Business Energy Audits will provide assessments of the current baseline emissions profile of businesses in York and North Yorkshire. Alongside the audits, businesses will be provided with recommendations and advice on how to improve energy use and reduce emissions based on the baseline audit results. The audits will support businesses from across the York and North Yorkshire region.
