It is recognised that historic data is not available due to predecessor organisations no longer in existence and pragmatic approach undertaken to determine contract modification thresholds adopting actual payments made in 2024/25, which calculates an estimated 12 month contract value as unable to predict actual payments due to patient demand led service.
