The following outcomes are anticipated as a result of the proposed procurement process to be carried out:

- To improve the overall quality of the active travel surfacing and infrastructure along New Street and upgrading the surrounding area (Temple Street, Lower Bennetts Hill, Ethel Street, Lower Temple Street, Eden Place, Chamberlain and Victoria Square Steps. The improvement of this public space will provide a new aesthetic for the city centre through its retail core, creating attractive spaces for residents, businesses and visitors.
