The CMS must adopt a headless, API first architecture; support granular content governance and approval workflows integrate with Entra ID (formerly Azure AD); and provide functionality for personalisation and A/B testing. The CMS and hosting solution must demonstrate GDPR compliance, ensure high availability and performance monitoring, and be supported by comprehensive training, maintenance, and ongoing support arrangements.
