Description of works.

This project involves the regeneration of the Canterbury castle grounds and the manufacture and installation of a new raised walkway within the historic castle keep.

Works will include:

Hard and Soft Landscaping:

- Earthworks
- Creating new soft landscape areas
- Creating new hard landscape areas using new and reclaimed historic paving and kerbs
- Installation of new street furniture including benches, bins and signage
- Installation of new lighting

Castle Keep - Viewing Platform:

- Manufacture and installation of castle walkway
- Hard landscaping works to the interior of the castle
- Installation of new lighting
