PSQ: Bidders will be invited to submit a PSQ that will be assessed against published criteria and ranked based on their weighted scores. Suppliers failing to meet minimum standards or mandatory criteria may be excluded. Top scorers' suppliers will be invited to participate in the ITT.

ITT: Suppliers will be invited to submit tenders based on initial requirements and evaluation criteria. Tenders will be assessed against published criteria and ranked based on their weighted scores. Suppliers failing to meet minimum standards or mandatory criteria may be excluded Suppliers not meeting the threshold for shortlisting will be excluded from further stages.
