### **Description**

A referral management service for managing ADHD referrals for NHS Staffordshire and Stoke, processing about 150 applications monthly. It includes clinical reviews, declining non-qualifying applications, and referring qualifying requests to pre-contracted providers for further assessment and treatment.

A provider has been identified who covers the geographical area of the ICB. This is a fixed cost contract.
