The deliverables will be: 9 x 3 storey town houses which can achieve passivhaus certification; improvement to the landscaping surrounding the new homes, improvements to the refuse storage arrangements for the estate and an additional accessible parking bay and an additional road entrance to serve the tower directly from Millfields Rd.
