Delivery to the locations and timescales as set out in the specification or as otherwise agreed between Braintree District Council and the Contractor.

It is intended that only one Lot will be awarded and the decision as to which of the Lots will be awarded will follow a whole life cost appraisal of each Lot and will take into consideration, the differential between black and coloured lids and available budget.
