Buckinghamshire New University ("University") has been working with Circuit Laundrette Services Ltd and this has been based on an income share concession arrangement. Of particular note:

This renewal will ensure continuity of services to students with the Supplier's proven support channels and includes the replacement of all washer and dryer equipment with brand new machines which will significantly improve the student experience.

These upgrades are expected to reduce maintenance issues, improve energy efficiency, and modernise the overall look and functionality of the facilities.

The value is approximate and has included a provision for any potential new accommodation sites the University may procure. It also isn't known exactly how many students will take up the offer of the free washes per term therefore an approximate contract spend has been provided.
