### Competitive flexible procedure description

The Tender Process will consist of 3 stages:

- Stage 1 (PSQ & ITT) - combined submission
- Stage 2 (Negotiations/BAFO) - Optional - minimum of 6x Bidders per Lot
- Stage 3 (Contract Award) - 3-5 Suppliers awarded per Lot

Bidder Tender Responses MUST be submitted via SAP Ariba, as a combined (PSQ & ITT) submission.

Following submission of Bidders' Tender Responses, it will be at the Contracting Authority's discretion to launch Stage 2 of the Tender Process. If the Contracting Authority decides not to proceed with Stage 2, the Award Decision would follow the outcome of

## Stage 1 of the Tender Process.

The PSQ evaluation is a pass / fail step of the Tender process, and Bidders must achieve a pass mark on all mandatory pass questions. If Bidders do not pass the PSQ, they will not progress to the next stage of the Tender Process and their ITT response will not be assessed in any form as part of the Tender Process.
