Description

The supplier will be responsible for sourcing, screening, onboarding, and managing temporary workers across various IT disciplines in line with Yorkshire Water's internal policies and regulatory obligations.

Services may include support for roles in development, infrastructure, data, security, and

digital transformation. Suppliers must provide transparent rate structures, ensure compliance with IR35 and other employment regulations, and integrate with internal workforce planning processes.

The lot is intended to increase visibility and control of contingent labour usage outside of IT, ensure pricing consistency, and reduce reliance on off-framework engagements.
