The service is for people of all ages. Children under 16 years must be accompanied at their appointment by an adult. Services include:

- Red eye(s) or eyelid(s)
- Dry, gritty or uncomfortable eye(s)
- Eye irritation and inflammation
- Recent discharge from the eye(s) or watery eye(s)
- Recently occurring flashes or floaters
- Painful eye(s)
- In-growing eyelashes

- Recent and sudden loss of vision
- Foreign body in the eye / emergency contact lens removal

Treatment for the above and onward referral as required.

NHS Derby & Derbyshire ICB are intending to award the contract to the existing provider following Direct Award Process C.

The approximate activity will be 1700 consultations.
