As part of this work North Yorkshire Council has secured funding to deliver heart health checks. This service offers screening for individuals to recognise the early signs of cardiovascular disease, which is one of the most prevalent primary conditions experienced by people who are economically inactive.

The contract will be in place from 8th October 2025 until 31st March 2026. The total contract value is £44,000.

Grant funding was made available to North Yorkshire Council on 22nd September 2025.

Under the conditions of the grant, all funding has to be spent by the end of March 2026. The

nature of the health checks means that if they are not delivered individuals with undetected

CVD risk factors could go longer without this being diagnosed and face a significant risk to their health. Therefore, the contracts were awarded using the urgent award procedure.
