NHS North East and North Cumbria Integrated Care Board (the Contracting Authority), are undertaking a procurement to commission LGBTQ+ Mental Health Support Service

Sunderland and South Tyneside under NHS Standard Contract 25/26 within the Sunderland and South Tyneside areas.

The contract term is for an initial period of 3 years commencing on 01 April 2026, with an option to extend for a further 2 years at the discretion of the Contracting Authority and subject to satisfactory contractual and financial performance.

The closing date for submission of tenders is by 12 noon 31 October 2025.

Firstly, the "Transfer of Undertakings (Protection of Employment) Regulations 2006" as amended by the "Collective Redundancies and Transfer of Undertaking (Protection of Employment) (Amendment) Regulation 2014" (TUPE) [may/does not] apply to this contract. Under the Public Services (Social Value) Act 2012, Contracting Authorities must consider:

Accordingly, the subject matter of the contract has been scoped to take into account the priorities of the Contracting Authority relating to "economic, social, and environmental well-being".

## **Award criteria**

The bidder who has passed each stage of the process and has submitted the Most Advantageous Tender (MAT) by scoring the highest combined score for quality and finance and passed Stage 1, evaluated against the published evaluation criteria, will be reported to the Contracting Authority as the Highest Scoring Bidder.

In the event that two or more bidders achieve the same combined score, the bidder with the highest overall score in the highest weighted macro section within the quality criteria will be as the most advantageous tender. In the event that two or more bidders still achieve the same score the rule will be applied to the next highest weighted macro section and so forth.
