VII.2) Information about modifications

VII.2.1) Description of the modifications

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

This modification is permitted under the Health Care Services (Provider Selection Regime) Regulations 2023 as it is in response to external factors beyond the control of the council and the provider i.e. the national NHS pay award, plus the contract stipulates that "The impact on the Service of future NHS pay awards will be considered by the Commissioner in conjunction with the Provider in order to agree a mutually acceptable resolution."

A recurrent uplift of £151,308 to the annual contract value due to the 2025/26 NHS pay award and net tariff inflator increase. The total increase in contract value from April 2025 to September 2029 will therefore be £680,886.
