The only mandatory requirements stipulated are that the provision should ensure

- a positive and equal catering experience for all DCG stakeholders across all sites to encompass provision for all dietary and legislative requirements i.e. Natasha's Law
- there are suitable food options for all DCG users throughout the day, including vending and branded offers
- bursary / free college meals are available for learners and barriers to uptake removed
- free breakfasts (currently toast) on GCSE exam dates
- Little Explorers Nursery is provided for within the catering offer including non-term time and closure to the main college - excluding over the Christmas period
- Pre ordered chargeable hospitality offers are available during college opening hours
- A continually evolving service to adapt to innovative new technologies and in demand market trends
