## **VII.2) Information about modifications**

### **VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

It was necessary to change our original provisionally awarded providers due to unforeseen circumstances.

KIDS, Home-Start in Suffolk and Go For It! were an original provisional award and have not changed. New awarded providers are The MAZE and Suffolk Family Carers who replace Autism Oxford and Oiza Healthcare Limited.

### **VII.2.2) Reasons for modification**

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

Two providers have changed from our original intention to award notice. One provider has ceased to trade and another was deselected following due diligence prior to entering into a contract. Appropriate procedures were followed to award to the next two providers on the list of ranked providers following the initial evaluation.
