The establishment of a framework for debt management service providers, the framework will be designed to bring together specialist capabilities in debt management, with managed service providers to collect debt on behalf of the government.

- managed debt collection services (managing multiple collection agencies),
- debt collection agency services (including International Collections),
- debt analytics (including open-banking and complimentary data and analytics),

- data aggregation and analysis services,
- debt analytics/solutions software and integration,
- debt advice and guidance services.
