Specific tasks will include but are not be limited to trolley rail joint repairs, replacements and rework on Quay cranes, Rubber tyred gantry cranes and rail mounted gantry cranes.

A preferred supplier stage will be entered into following the completion of tender assessments, this will allow for contract terms negotiations to be finalised if required.
