Name	Description	Type	Weighting
Price Criteria	The lowest price submitted will be allocated a score of 100% with the remaining prices submitted allocated a score on a pro-rated % basis. For example, if the lowest bid submitted by tenderer A was £1,000,000, and the second lowest bid by tenderer B was £1,100,000, tenderer A would be allocated a score of 100% and tenderer B a score of 90.90% ($\text{£1,000,000} \div \text{£1,100,000} \times 100$). When the 60% weighting was applied, tenderer A would be allocated a final total score for the price element of 60% ($100 \times 60\%$) and tenderer B a score of 54.54% ($90.90 \times 60\%$).	Price	70.00%
Quality Criteria	Each of the 6 questions will be allocated a total of 5% and each element will be scored as a proportion of that percentage	Quality	30.00%
