This is a Provider Selection Regime (PSR) confirmation of contract award notice.

The contracts for:

Lot 1 - 111 Online Services (North East Wide)

Lot 2 - Primary Care Speak To Dispositions (Northumberland, North Tyneside and Newcastle)

have been awarded under the Health Care Services (Provider Selection Regime) Regulations 2023.

For the avoidance of doubt, the provisions of the Procurement Regulations 2024 (Procurement Act 2023) do not apply to this award.

The contracts for Lots 1 and 2 have now been formally awarded using the Competitive Process.

The contract periods for Lots 1 and 2 are for 2 years, with effect from 01 October 2025, with the option to extend for a further 2 years, subject to satisfactory financial and contractual performance and at the discretion of the Relevant Authorities.

The contract values are:

Lot 2 - Primary Care Speak To Dispositions (Northumberland, North Tyneside and Newcastle) £2,560,000
