### **VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

The Borough Council of Sandwell wishes to utilise the option to extend for Lot 1 School Health Nursing, from 01/04/2025 to 31/03/2027 and also modify the cost model to include staff cost increase due to Agenda for Change uplifts and the agreement of a reconfiguration of the cost model to ensure Value for Money, this also includes a slight increase to the management fee, from 6% to 7%.

Lot 2 Child Vision Screening Services, will not be extended under this contract beyond the initial term of 01/04/2022 to 31/03/2025.

### **VII.2.2) Reasons for modification**

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

A competitive process was undertaken in line with The Health Care Services (Provider Selection Regime) Regulations 2023 using the Competitive Process. At the time of the tender deadline no submissions were received, and a decision was made to abandon the procurement.

A decision was made to undergo an extension and variation, to increase the current contract value, for the extension period regarding Lot 1 - School Nursing Service.

For Lot 2, Child Vision Screening, a decision was made to not extend the service beyond its initial term.
